

CIRCULAR LETTER No. 3/2026

of the Rector of Koszalin University of Technology
dated 31 August 2026

on determining the fees for the use of places in student dormitories at 11–15 Rejtana Street from
the 2026/2027 academic year

§ 1

1. The monthly fees for a place in the student dormitories at the student residential complex at Rejtana Street in Koszalin, for students and doctoral students of Koszalin University of Technology, shall be as follows:

Student Dormitory No. 3:

a) in a single room – PLN 750.00/month

b) in a double room – PLN 600.00/month/person

2. The fees for accommodation in a student dormitory for persons forming a joint household with a student/doctoral student of the University and occupying a place in the same room shall be as follows:
 - 1) the spouse/partner of a student/doctoral student – full fee according to the rates specified in § 3(1),
 - 2) children of a student/doctoral student up to the age of 4 – exempt from fees,
 - 3) children of a student/doctoral student up to the age of 18 – 50% of the fees specified in § 1(1).
3. The fee for students/doctoral students of Koszalin University of Technology using overnight accommodation shall be PLN 85.00 per place/day (incidental accommodation or accommodation during the examination session).
4. The fee for persons visiting a student/doctoral student shall be PLN 85.00 per place/day.
5. The deadlines and rules for payment of the fees specified in § 1(3) and (4) shall be determined by the Head of the Student Dormitories Department.
6. All rates specified above are gross prices.

§ 2

An employee who is simultaneously a student/doctoral student shall pay the fee applicable to a student/doctoral student.

§ 3

1. The monthly fees for a place in the student dormitories at the student residential complex at Rejtana Street in Koszalin **shall be paid in the full monthly amount regardless of the date of accommodation and check-out during the month.**
2. Fees shall be paid by the **10th** day of the month for the current month.

§ 4

1. A student/doctoral student/employee of Koszalin University of Technology holding a certificate of a significant degree of disability may be provided with accommodation in a

student dormitory, depending on their needs and the possibility of adapting the premises to the situation of the person with a disability.

2. A student/doctoral student/employee of the University holding a certificate of a significant degree of disability shall pay fees amounting to 50% of the fees specified in this Circular Letter.

§ 5

1. Persons accommodated in the student dormitories at the student residential complex at Rejtana Street in Koszalin shall lose the right to accommodation in the student dormitory if they are in arrears with payments for two billing periods.
2. Statutory interest for late payment shall be charged on the amount due to the University as a result of an unpaid fee for each day of delay. The University shall issue and deliver an interest note to the debtor together with a demand for payment to the e-mail address provided by the debtor upon registration.

§ 6

1. The provisions of this Circular Letter shall enter into force on 1 October 2026.
2. As of the date on which the provisions of this Circular Letter enter into force, Circular Letter No. 4/2025 of the Rector of Koszalin University of Technology dated 29 September 2025 on determining the fees for accommodation in the student dormitories and the Assistant Hotel of Koszalin University of Technology shall cease to have effect.
