## **CIRCULAR LETTER No. 4/2025**

of the Rector of Koszalin University of Technology of September 29, 2025. on determining the fees for the use of places in student dormitories since the academic year 2025/2026

§ 1

1. The monthly fees for a place in student dormitories for students, doctoral students and foreign students of Koszalin University of Technology are as follows:

## in Dormitory No. 3:

• in a single room PLN 670.00/month

• in a double room PLN 500.00/month/person

- 1. Accommodation fees for persons forming a household with a student/doctoral student of the university, sharing a room with them, are as follows:
  - spouse/partner of the student/doctoral student full fee according to rates in § 1 (1),
  - children of the student/doctoral student up to 4 years of age are exempt from fees,
  - children of the student/doctoral student up to 18 years of age pay 50% of the fees specified in § 1(1).
- 2. The fee for students/doctoral students using accommodation on an incidental basis or during the exam session is PLN 50.00 per place/night.
- 3. The fee for guests visiting students is PLN 60.00 per place/night.
- 4. Deadlines and rules for paying the fees specified in § 1(2) and (3) are determined by the Head of the Dormitories Department.
- 5. All rates are gross prices.

§ 2

- 1. The fee for renting accommodation for non-students/doctoral students of the university: PLN 95.00 per day/person (VAT included).
- 2. Deadlines and rules for paying the fees specified in § 2(1) are determined by the Head of the Dormitories Department.

- 1. Monthly accommodation fees in student dormitories at Rejtana Street in Koszalin are payable in full for the entire month, regardless of the date of check-in or check-out within the month.
- 2. Payments must be made by the **10th day** of the month for the current month.

§ 4

- A student/doctoral student/employee of Koszalin University of Technology with a ruling of severe disability may be granted accommodation in a dormitory or in the Assistant Hotel, depending on needs and possibilities of adapting the premises to the person's situation.
- 2. Students/doctoral students/employees of the university with a ruling of severe disability pay 50% of the fees specified in this Circular.

§ 5

Persons accommodated in the student dormitories at Rejtana Street in Koszalin lose their right to reside there if they are in arrears for two settlement periods. Statutory interest for delay will be charged on overdue payments for each day of delay. The university will issue an interest note and deliver it to the debtor at the email address provided at check-in.

§ 6

- 1. The provisions of the Circular Letter shall enter into force on October 1, 2025.
- On the date of entry into force of the provisions of this Circular Letter, Circular Letter
   No. 3/2024 of the Rector of Koszalin University of Technology dated 18 September 2024
   shall expire.
